Licensure and Certification After Graduation – Nurse Anesthesia

To receive initial Advanced Practice Nursing licensure in Alabama as a certified registered nurse anesthetist (CRNA), one must have an unencumbered license as a Registered Nurse (RN) in Alabama or a VALID multi-state license (MSL-RN) from a compact state, an earned Master's or higher degree in nursing from an educational institution in a curriculum designed to prepare nurse anesthetists, and certification from the National Board of Certification and Recertification for Nurse Anesthetists (NBCRNA). The nurse anesthesia program offering the Doctor of Nursing Practice degree is accredited by the Council on Accreditation of Nurse Anesthesia Educational Programs (COA), a specialized accrediting body recognized by the Council on Higher Education Accreditation and the United States Department of Education. The Moffett & Sanders School of Nursing and the Doctor of Nursing Practice degree are accredited by the Commission of Collegiate Nursing Education (CCNE).

As of May 20, 2024, Samford has investigated to confirm that the program meets the educational requirements leading to professional licensure in all states. If you intend to practice in any state other than Alabama, you should contact the appropriate licensing agency to independently verify whether Samford's program satisfies the educational requirements for licensure in a particular state before beginning the program. It is important to note that state licensure requirements may change from time to time and that states may have conditions for licensure in addition to educational requirements.
