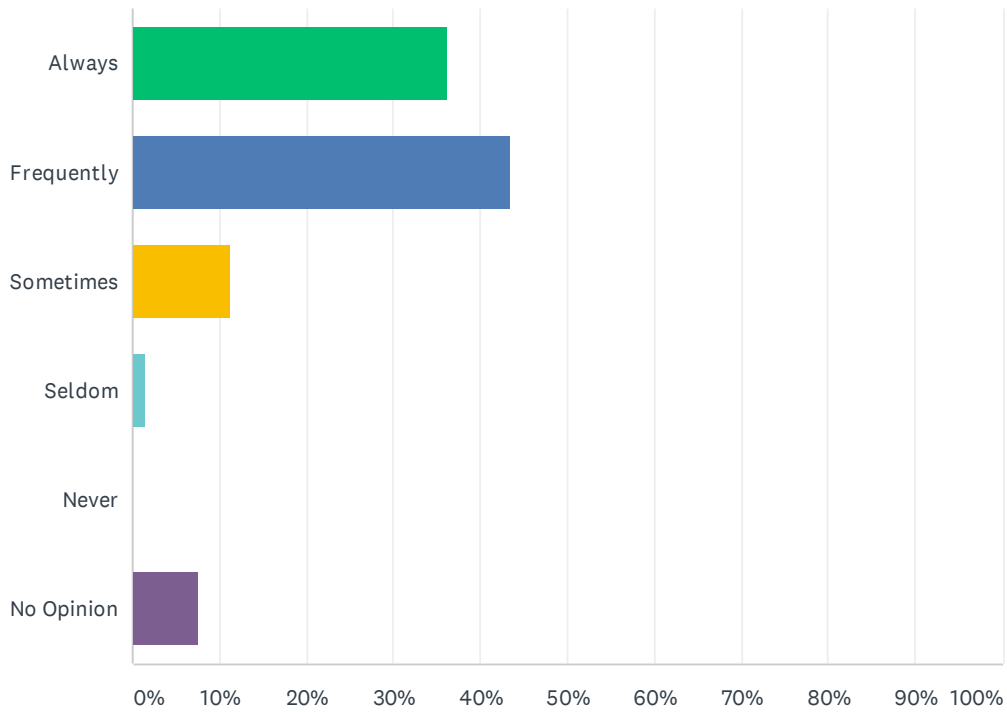


Q1 When you visit the law library, are you able to find what you're looking for?

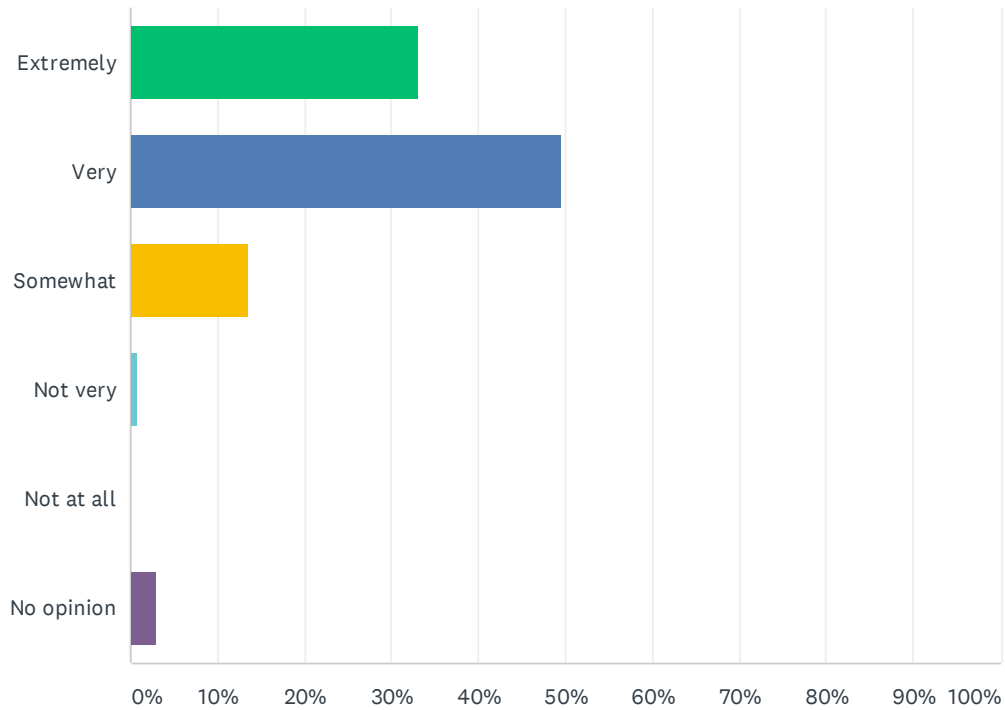

Q2 How satisfied are you with the overall services of the law library?

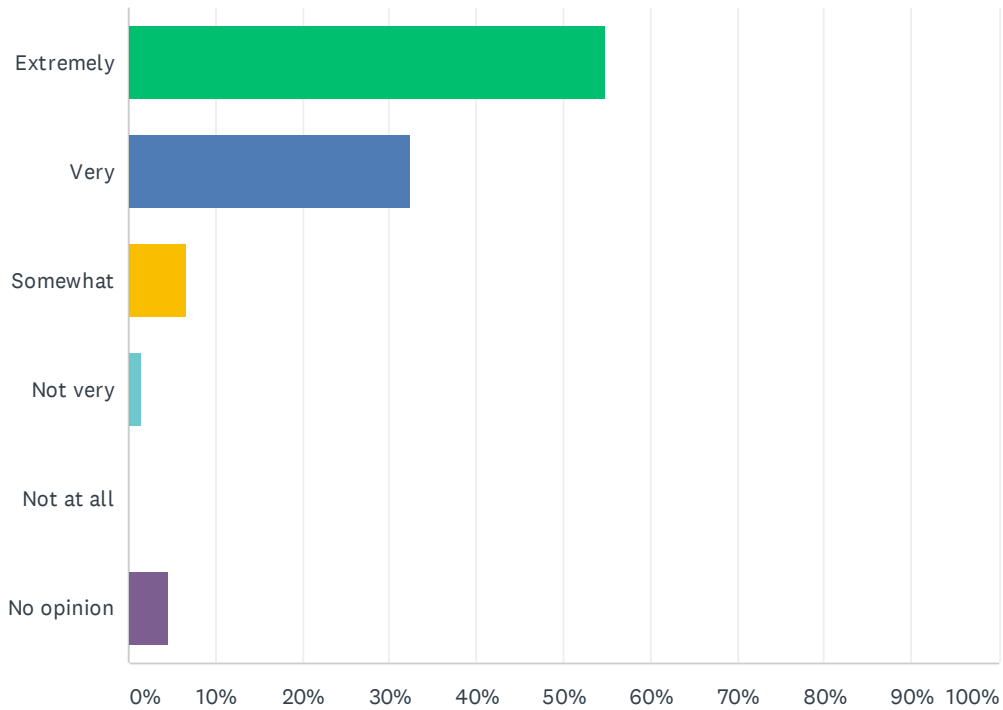

Q3 How helpful is the law library staff?

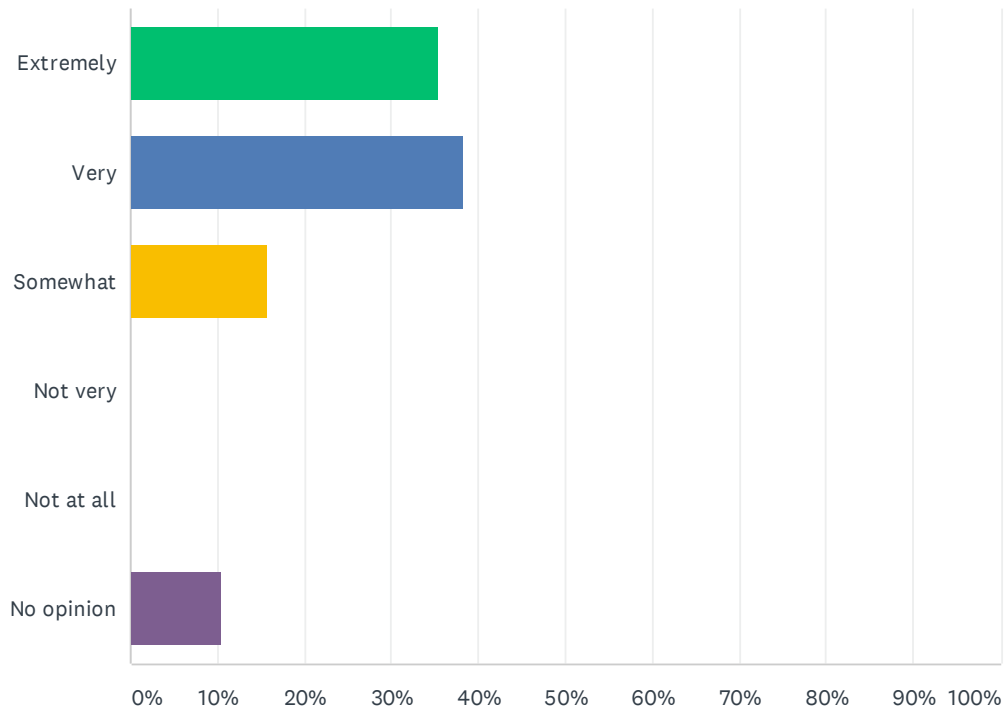

Q4 How satisfied are you with the information resources (books, periodicals, online databases, etc.) available through the law library?

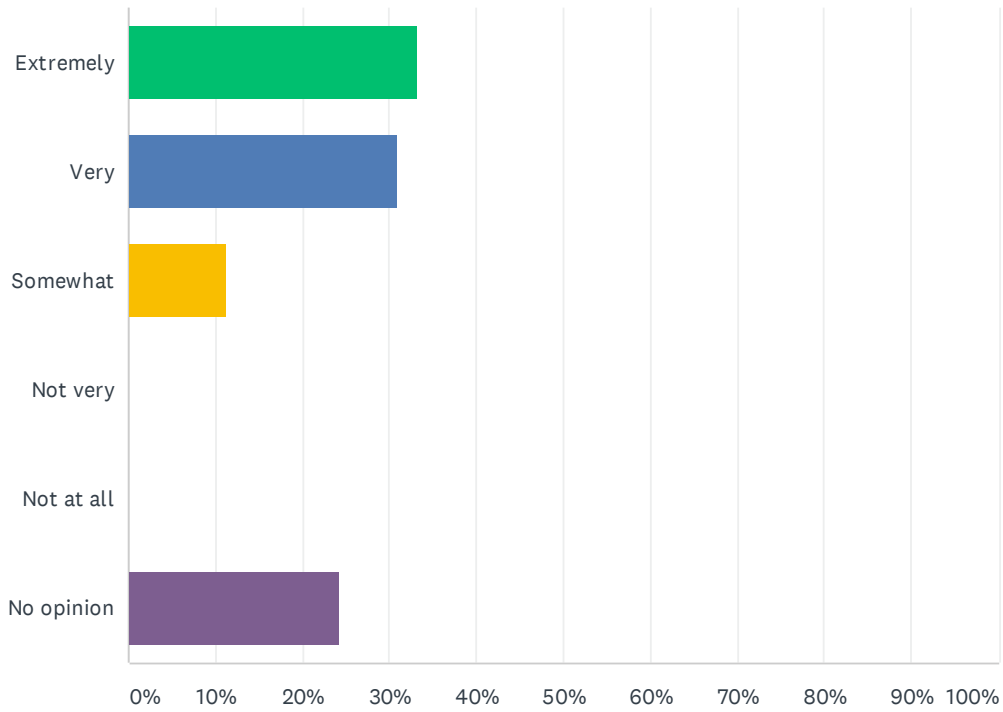

Q5 How satisfied are you with law library's reference services?

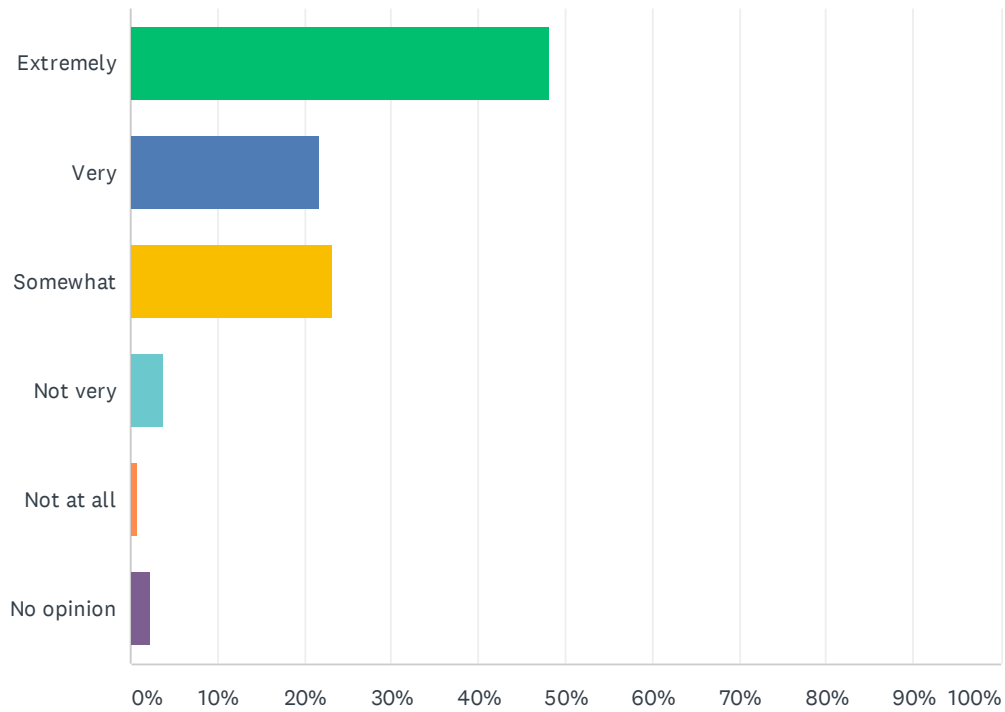

Q6 How satisfied are you with law library’s information technology services (computer labs, support, etc.)?

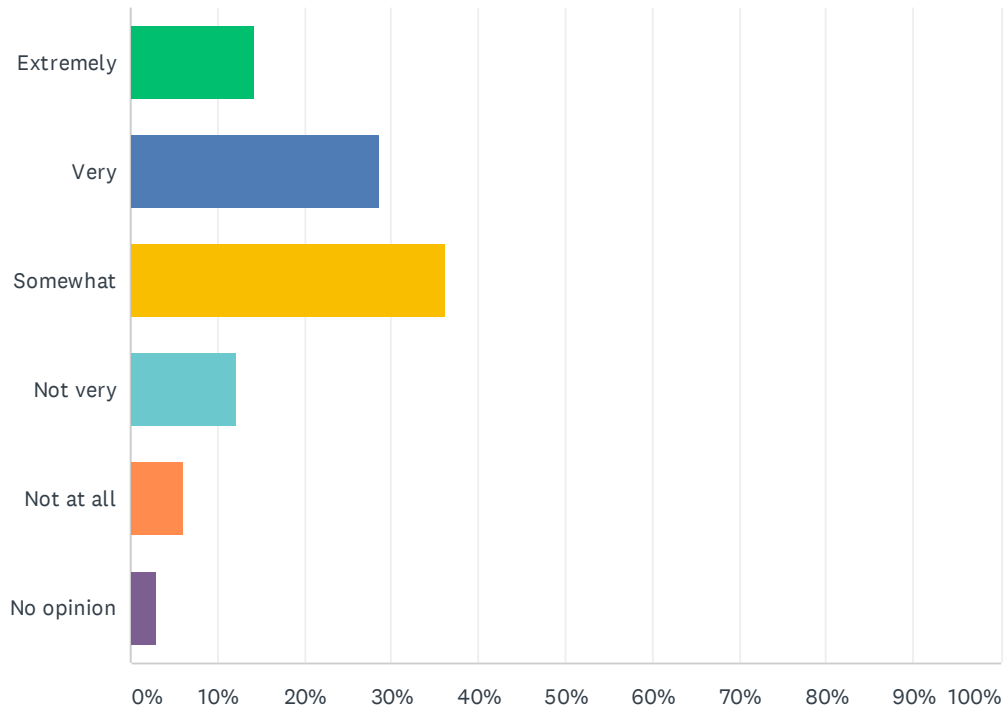

Q7 How satisfied are you with law library's hours of operation?

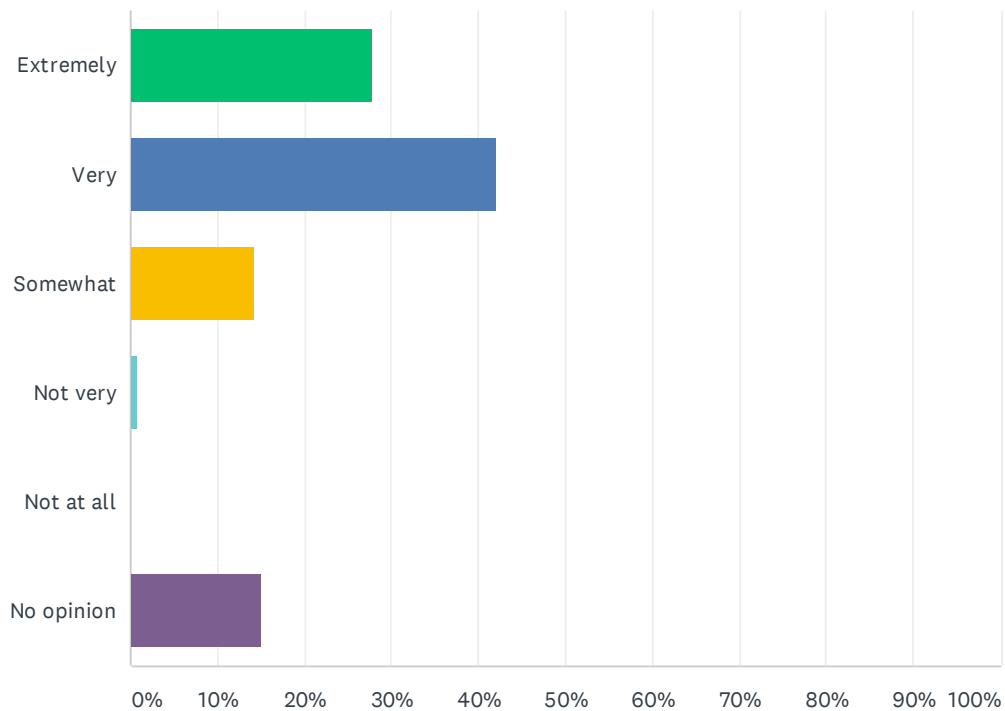

Q8 How satisfied are you with the resources available through the law library to locate information which you need (the online catalog, digests, indexes, etc.)?

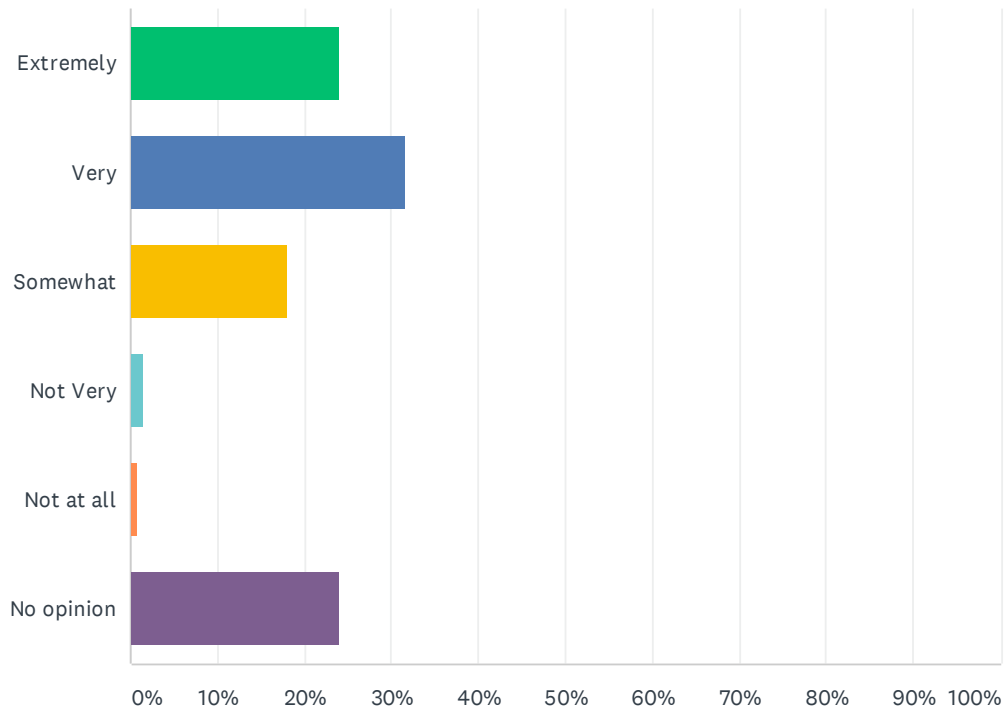

Q9 How easily can you find the books and journals you need in the library catalog?

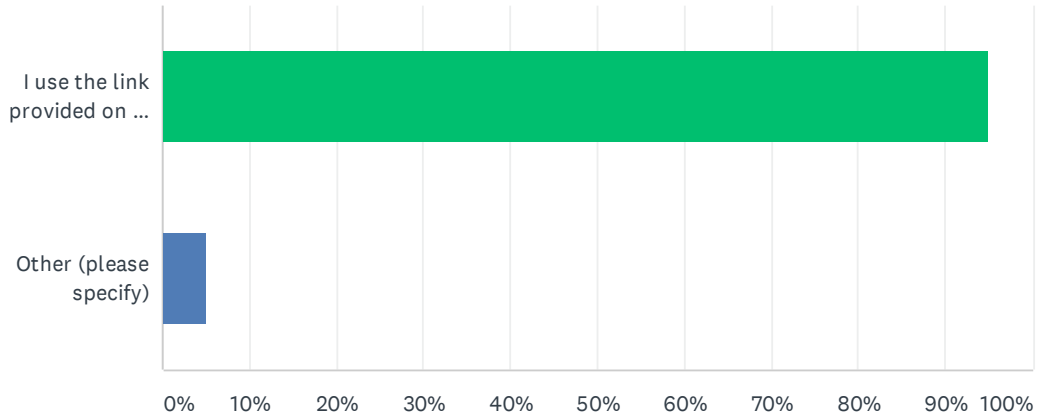

Q10 How do you typically access the library catalog?

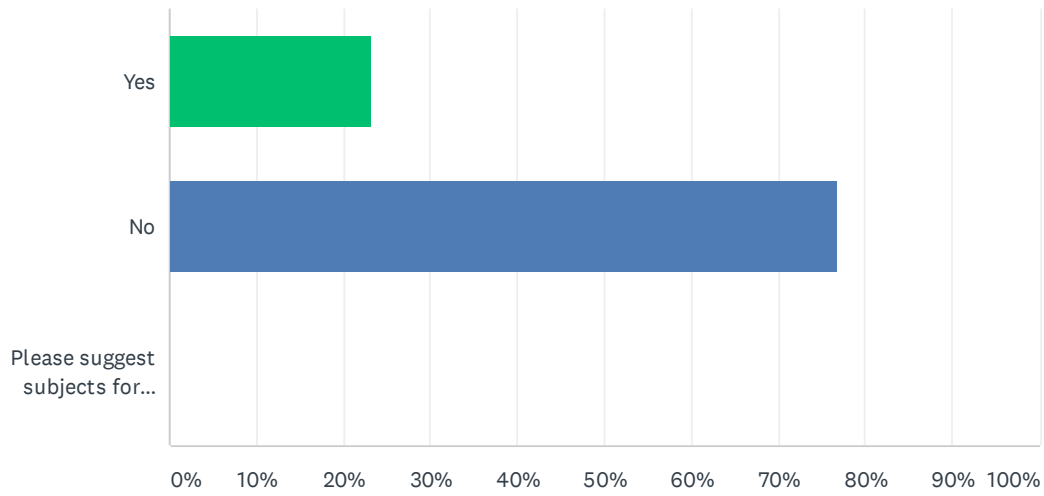

Q11 Have you used a subject Research Guide on the Law Library web site?

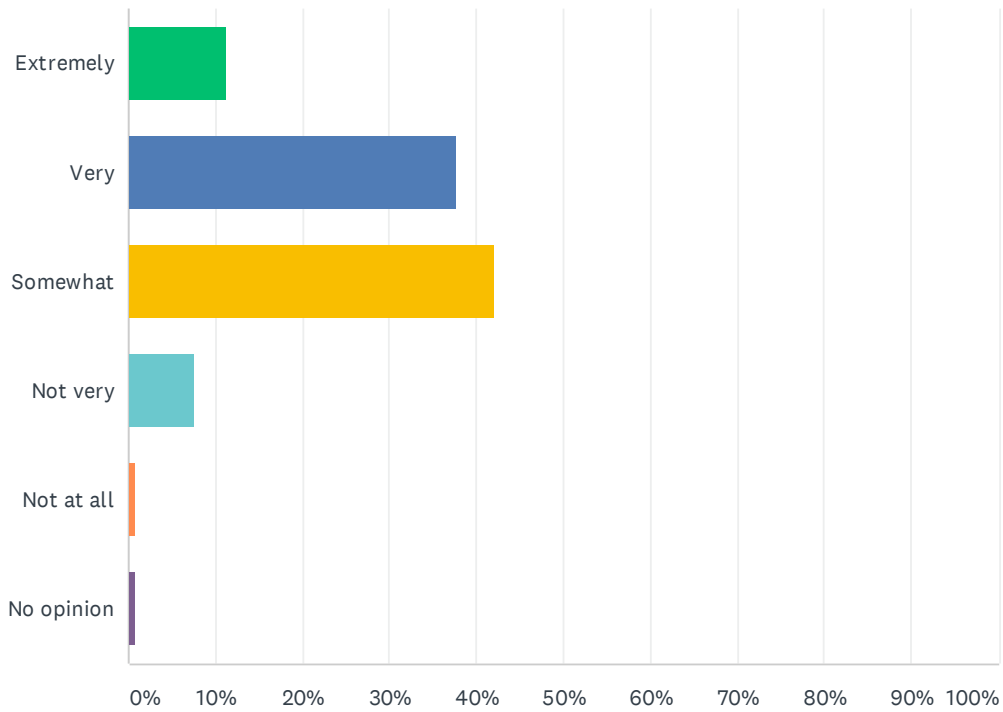

Q12 How satisfied are you with the law library's physical space and furnishings?

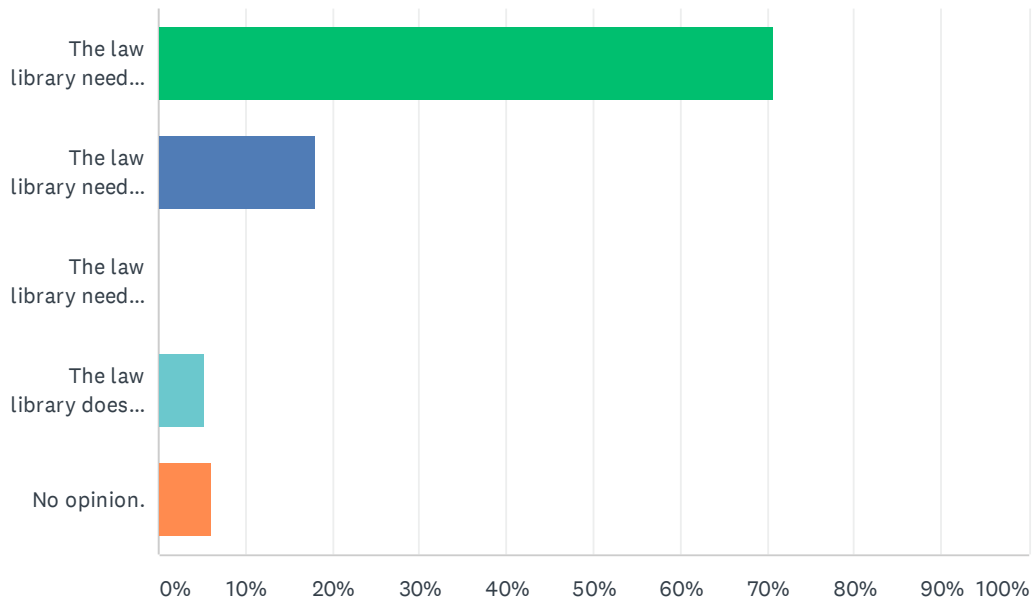
